CONSENT, ASSUMPTION OF RISK, AND LIABILITY RELEASE

In consideration of Youth Serving Christ, Inc. ("YSC") permitting me, my minor child or ward, principal etc. to participate in YSC events or activities, the undersigned, personally and on behalf of the undersigned's heirs, next of kin, assigns, wards, attorney in fact, principals, and personal representatives, do hereby agree to the following:

1. I understand that participating in a bicycling event requires mental, emotional, and physical conditioning----- and I represent that I and those on whose behalf I am signing, am in sound mental, emotional, and medical condition, capable of participating in YSC events, rides, and activities without risk to myself or others, have no known mental, emotional or medical impairment which would pose a danger or risk, and agree that I will be solely responsible for the condition, maintenance and adequacy of my bicycle, safety gear, and riding equipment. I, and those on whose behalf I am signing, will ride safely within the limits of their respective abilities, my equipment, and the riding conditions, and in a manner so as not to endanger themselves or others.

2. I understand that the undersigned's photograph, voice, and/or likeness may be used in promotional or advertising materials. I consent to such uses and waive any rights of privacy or publicity I may have in connection with those uses.

3. I understand that participating in a bicycle riding is a potentially hazardous activity which involves risks, inherent and otherwise, known or unknown, that cannot be eliminated which may cause injury, illness, paralysis, death, emotional injury, person injury, property damage, and financial damage and I accept all these and more risks and financial responsibility therefore including such risks and financial responsibility arising out of any medical treatment rendered by YSC, including its officers, board members, employees, members, volunteers, contributors and sponsors (in this document collectively and individually "Release"). I further understand and accept the risks arising out of the negligence of, or other risks associated with this YSC event or activities related thereto may cause injury, illness, paralysis, death emotional injury, person injury, property damage, and financial damage. Some of the risks I accept that are associated with this event, ride, and activities include, but are not limited to: collisions with other riders, pedestrians, animals (domestic or wild), terrain, objects, or vehicles; injuries arising out of riding in a YSC provided vehicle, traffic, highway crossings; route, station, shelter and set up planning, installation, maintenance and operation; equipment capability, failure or malfunction including helmets; my or others known or unknown mental, emotional, and medical conditions; contaminated or spoiled food and drink; medical treatment rendered; transportation; dehydration; and weather conditions. I accept, assume full and sole responsibility for all risks, both known and unknown, inherent or otherwise, related to this YSC event, ride, and activities. Further, I am voluntarily participating in this activity with knowledge of the risks and fully accept and assume all risks related to or arising from YSCs events, rides, and activities. I understand YSC is not responsible for providing security or safety of any kind or in any form for this event..

4. Acknowledging that such risk exists, I PERSONALLY AND ON BEHALF OF MY MINOR CHILD, WARD OR PRINCIPAL HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE YSC ITS OFFICERS, BOARD MEMBERS, OFFICIALS, MEMBERS, VOLUNTEERS, DONORS, AND SPONSORS, and the officers, directors, employees, representatives, agents, insurers, and successors of all the above (hereinafter individually and collectively referred to as the "Releasees") from any and all claims, damages, losses, actions, suits, proceedings, breach of contract, warranty, actions, wrongful death actions, expenses, attorney fees, and liability that I, anyone on my behalf, my heirs, next of kin, or minor child might have for, or relating to, any injury, including death, to my person or that of my minor child or property suffered or claimed to have been suffered by me which arises out of or is related in any manner, either directly or indirectly, to my or my minor child's participation in any YSC event, ride, or activity or my assistance at any YSC event, ride, or activity, including but not limited to, any claim that the act or omission complained of was caused in whole or in part by the negligence in any form of the Releasees. YSC volunteers have no duty to indemnify, defend, or hold harmless the Releasees. I understand that YSC undertaking, in whole or party any action such as but not limited to safety, warnings, or provision of minor medical supplies is not an assumption of risk or a waiver of any of the terms hereof even if I relay to my detriment thereon.

5. I further agree to INDEMNIFY, HOLD HARLESS AND DEFEND the Releasee in any action or proceeding against all lawsuits, losses, damages, actions suits, proceedings and expenses, including attorney fees and costs arising from or relating in any respect to my or my child's, ward's or principals, participation in this YFC event or my breach of this agreement, regardless whether the act or omission was caused in whole or in part by Releases negligence in any form.

6. I understand that I am solely responsible for at all times the supervision, direction, protection and safety of any minor, ward, mentally or physically impaired person on whose behalf I am signing.

7. This document is governed by the laws of the state of Indiana. If one or more portions of this document are found unenforceable, the remainder of the document will remain enforceable. If I am a minor, my parent or guardian is also signing individually and on my behalf and we both agree to be bound by the terms of this agreement.

I have fully read and fully understand this Waiver and Release of Liability and Indemnity Agreement and agree to be bound by its terms. I understand that by signing this document I may be waiving certain legal rights, including the right to sue any Releasee. I sign this document freely and willingly.
